



VIP EXPERIENCE RAFFLE: OFFICIAL RULES



WHO CAN ENTER

- To be eligible to participate in the IAM VIP Experience Raffle, entrants must be registered and paid in full for the IAM 58th Annual Meeting and Expo held at the Manchester Grand Hyatt San Diego by Friday, August 29, 2020, 5:00 PM Eastern Standard Time, (EST).
- Employees of International Association of Movers, Inc. (IAM) and their affiliated companies, the immediate family members of each are ineligible. The term "immediate family" includes spouses, grandparents, parents, siblings, children and grandchildren.
- Eligibility for the IAM VIP Experience Raffle is for members of IAM. Membership must be in good standing by the time of registration.
- Eligibility is not offered to Expo Hall Only attendees.

HOW TO ENTER

- Enter online at www.iammeetings.org
- A purchase of the 58th Annual Meeting and Expo registration is necessary to enter. Only one entry allowed per attendee.
- To enter, log onto www.iammeetings.org to register and pay in full.
- The raffle starts on Tuesday, May 26, 2020 at 12:00 Noon, EST and all entries must be received by Friday, August 28, 2020 by 5:00 pm, EST. IAM is not responsible for lost, late, or misdirected entries, server unavailability, computer, or any other electronic malfunction.
- On Monday, September 21, 2020 one (1) winner will be selected by random drawing from among valid entries.

THE PRIZE(S)

- The winner will be notified by email provided at the time of registration. The winner must provide his/her correct name, address and telephone number to IAM at the time of registration. The winner must sign and return an acceptance of prize and release of liability form, which must
