



## VIP EXPERIENCE RAFFLE: OFFICIAL RULES



### WHO CAN ENTER

1. To be eligible to participate in the IAM VIP Experience Raffle, entrants must be registered and paid in full for the IAM 61st Annual Meeting and Expo held at Metro Toronto Convention Centre in Ontario, Canada by Tuesday, September 19, 2023, 5:00 PM Eastern Standard Time, (EST).
2. Employees of International Association of Movers, Inc. (IAM) and their affiliated companies, the immediate family members of each are ineligible. The term "immediate family" includes spouses, grandparents, parents, siblings, children and grandchildren.
3. Eligibility for the IAM VIP Experience Raffle is for members of IAM. Membership must be in good standing by the time of registration.
4. Eligibility is not offered to Expo Hall Only attendees.

### HOW TO ENTER

1. Enter online at [www.iammeetings.org](http://www.iammeetings.org)
2. A purchase of the IAM 61st Annual Meeting and Expo In-Person registration is necessary to enter. Only one entry allowed per attendee.
3. To enter, log onto [www.iammeetings.org](http://www.iammeetings.org) to register and pay in full.
4. The raffle starts on Thursday, April 13, 2023, at 12:00 Noon, EST and all entries must be received by Tuesday, September 19, 2023, by 5:00 pm, EST. IAM is not responsible for lost, late, or misdirected entries, server unavailability, computer, or any other electronic malfunction.
5. On Thursday, September 25, 2023 one (1) winner will be selected by random drawing from among valid entries.

### THE PRIZE(S)

1. One (1) winner will be selected.
2. The winner will be notified by email provided at the time of registration. The winner must provide his/her correct name, address and telephone number to IAM at the time of registration. The winner must sign and return an acceptance of

prize and release of liability form, which must be received within three (3) business days of notification.

If the selected winner has not both acknowledge the winnings and returned the acceptance of prize and release of liability form within three (3) business days of notification, then the prize will be forfeited, and the prize will be awarded to an alternate winner randomly selected from among remaining valid entries.
